



The need for chemical safety for human health protection and environment


Chemical safety involves the identification of a hazard and a scientific assessment, ideally quantitative, of the risks of exposure, leading on to decisions of the need to manage the risks



The sound management of chemicals was recognized as crucial for the protection of human health and the environment at the United Nations Conference on Sustainable Development Rio+20, held in June 2012. The future we want recognizes growing global production and use of chemicals and their prevalence in the environment, calling for effective implementation and strengthening of SAICM as part of a robust, coherent, effective and efficient system for the sound management of chemicals throughout their life cycle, including to respond to emerging challenges The UNEP Governing Council 27, 2013, also encouraged governments and other stakeholders to promote safer, effective alternatives, including non-chemical alternatives, and to adopt measures to prevent industrial chemical accidents and unintended releases and emissions in order to prevent rather than remediate April 11, 2013 - Workshop: A.Mihajlov




Na RTV POČELO EMITOVANJE "ODGOVORNOG POTROŠAČA"



ENSPLOZIVNO VEOMA LAK D ZAPAL UVO OKSIDUJUĆI **Nedija** Ce ja Centar Beograd SUPSTANCE I SMESE GASOVI POD PRITISKOM AKUTNA TOKSIĆNOST Ielena Cvetković (Medija centar) Usled neinformisanosti i nedovoline svesti o opasnostima i rizicima koje nose hemikalije, kao i zbog nepravilne upotrebe hemikalija zabeležen je veliki broj trovanja hemikalijama. Prema podacima Centra za kontrolu tro-vanja VMA najveći broj slučajeva trovanja hemikalijama u Srbiji je izazvano korozivima i pesticidima. Kako bi upotreba hemikalija bila bezbedna za potrošače, Agencija za hemi-kalije uspostavila je sistem koji je u potpunosti usklađen sa propisima koji važe u Evropskoj uniji. Svi koji proizvođe ili trguju hemikalijama ili proizvođima AKUTNA TOKSIČNOST SENTIBILIZACIJA IKATORNIH ORGAN **EIVOTINU SREDINU** koji ili sadrže, obavezni su da evidentiraju takve proizvode. Propisi imaju za cilj da se na tržišu uopšte ne nadu proizvodi koji predstavljaju neprihvatljiv rizik po životnu sredinu i zdravlje ljudi. Oznake po sistemu DSD/DPD Direktorka Agencije za hemikalije Jelena Cvetković, za Potrošački reporter kaže da je ovim pravilnikom preko hiljadu hemikalija na tržištu Srbije zabranjeno ili strogo ograničeno. "Naročito se te zabrane i ograničenja tiču predmeta opšte upotrebe. "varočno se te zabrane i ogranicaja trču predneta opice upotrede. Potrošač će te informacije nači na pakovanju, odnosno etiketi te hemi-kalije u vidu oznaka (piktograma). Međutim jako je važno da pored grafičkog upozorenja potrošač obrati pažnju i na sve druge ele-mente na deklaraciji, kao i na uputstvima." - kaže Jovana Cvetković. Aprilski dani hemije u Beogradu Agencija za hemikalije Republike Srbije u saradnji sa tvining projektom "Pomoć u implementaciji sistema upravljanja hemikalijama u Srbiji" koji finansira Evropska unija započinje seriju aktivnosti "Bezbedno sa hemikalijama Cital etiketu!" U sredu 18. aprila 2012. godine na Aprilskim danima hemije u orga-nizachi Hemijskog fakulteta u Beogradu upoznaju svoje kolege sa ovim pi-lot projektom kako bi i oni u svojim školama organizovali ovakve projekte i HOROZIVNO TONS TOKSICNO STETNO IN CONTROL razmotrili uvođenje novih saznanja iz ove oblasti u nastavne programe hemije. Upoznavanje učenika Hemijsko-prehrambeno tehnološke škole sa pravilnim obeležavanjem opasnih hemikalija i načinom njihovog držanja u maloprodajnim objektima rezultiraće dinamičnim radionkama u maloprodajnim objek-tima. Krajem aprila učenici će uz pratnju profesora posetiti nekoliko prodajnih objekata informisati potrošače o tome kako da pravilno pročitaju etiketu, kako da bezbedno koriste hemikaliju, kao 1 o tome gde bi trebalo da se drže hemikalije u njihovim domovima, ali i u prodajnim objektima. - Focused to variety of stakeholders






How to support CSOs when national Governmental level perform like:

Chemical Agency abolished.

The helpdesk of the (former) Serbian Chemicals Agency, with observer status with the European Chemicals Agency, do not exist anymore.

Unit for chemicals within competent Ministry, in April 2013 still do not exists (from 42 staff members in former agency it comes to unknown structure related chemicals). Agency's (Agency for Chemicals) transferred competences and administrative capacity is not preserved, until now.



Serbia) media...

Seems that the most effective related support to CSOs should be targeted to:

- Knowledge based advocacy and promotion on chemical safety
- Knowledge based courses/education of all stakeholders ... CSOs, including consumers, decision makers,
- Knowledge based monitoring of legal and institutional developments/consequences at national level



- Education: like support development of "curricula" on chemical safety for international Eco-Schools Program implementation in Serbia
